
1. WHO IS THIS DOCUMENT FOR?

6. DO WE PROVIDE YOUR PERSONAL DATA TO THIRD PARTIES?

Yes. Your personal data are provided to third parties only for legitimate reasons, such as fulfilling contractual requirements, where no consent is required. For example:

- § Name, surname and phone number in the carrier's cloud service for the purpose of delivery of a shipment
- Name, surname and phone number in the cloud service (Outlook, web form) for the purpose of business §
 - Personal data provided to the EU grant provider (the type of personal data depends on the conditions of the given
- § Personal data in administrators' databases
- Forwarding emails with customer contact information to third parties for the purpose of completing a business §
- § Public - information on the website, in the company magazine, marketing material, etc.

Without your consent, your personal data are not used unless a legitimate legal basis for processing personal data is fulfilled.

7. WHAT HAPPENS TO MY DATA AFTER OUR RELATIONSHIP ENDS?

After the termination of our mutual relationship, your personal data are disposed of by the following actions:



Your personal data that are already physically printed on a document (e.g., delivery note, invoice) are destroyed by shredding after the retention period of the given document has expired, in accordance with the Document Directive. Personal data provided for the purpose of granting subsidies are stored on a third-party portal according to the terms and conditions of the contracting authority.

8. WHAT RIGHTS DO I HAVE?

9. HOW ARE MY DATA SECURED?

CODACO has implemented appropriate technical and organizational measures to protect data against unauthorized use.

According to the place of storage and processing of the personal data, the following measures are applied to secure the personal data:
